(b) Questions on Notice to Ministers for Oral Replies

(i) Questions Brought Forward from Previous Order Papers

***461 Hon. M. Malowa (Chiradzulu Central)** To ask the Minister of Education to consider constructing a Teacher Development Centre Office at PIM Zone. The PEA for this zone has no office.

***462 Hon. E. Chambulanyina Jere (Mzimba South)** To ask the Minister of Education as what is the ministry's plan on MSIP projects that were advertised in the papers for contractor bidding but nothing to date. In my constituency, there was Mzomazoma and Kachiwale where a ministry official came and made commitment that we would have these new school blocks but up to now nothing has happened on the ground. People are now wondering as to why there is no progress to date.

***474 Hon. K. Pemba Kachingwe (Blantyre Rural South West)** To ask the Minister of Education to consider constructing fences and a girls hostel at the following:

- (i) Mpemba CDSS;
- (ii) Nankumba CDSS;
- (iii) Mpapa CDSS; and
- (iv) Madziabango CDSS

***475 Hon. F. Phiso (Blantyre North)** To ask the Minister of Education to consider constructing hostels at Namikasi and the Big Secondary Schools since at the moment most of the students are compelled to find their own accommodation and this becomes a challenge especially to the girl child.

MINISTRY OF JUSTICE

***463 Hon. Dr. Kenneth Zikhale Ng'oma (Nkhata Bay South)** To ask the Minister of Justice to consider constructing a magistrate court at Kande Trading centre where Senior Chief Fukamapiri operate from. People travel long distances to go to Chintheche for such services.

MINISTRY OF LOCAL GOVERNMENT

- *465 Hon. S. Mikaya (Blantyre City West)** To ask the Minister of Local Government to consider the construction of Nancholi market. The current market place is an accident prone area as people are trading on the roads which is putting their lives at risk.
- *476 Hon. C. Chipungu (Thyolo South West)** To ask the Minister of Local Government to consider the completion of T.A. Changata's house that has stalled due to unknown reasons.
- *477 Hon. A.R. Kalitendere (Machinga North East)** To ask the Minister of Local Government to elevate T.A. Chiwalo to Senior Chief as this chief has been at the same position since colonial rule and part of his area was given to Senior Chief Kapoloma. Several requests have been sent to the ministry but up to date he has not been elevated.
- *478 Hon. G. Kapiseni Phiri (Salima Central)** To ask the Minister of Local Government to consider upgrading Sengabay Market to a rural growth centre to reflect as a tourist area and also consider constructing a modern market at Kaphatenga Trading Centre.
- *483 Hon. N. Dausi (Mwanza Central)** To ask the Minister of Local Government on the progress of Mwanza Community Stadium that was earmarked to be launched but up to this time. When will the stadium and the Bus Depot come into operation.

MINISTRY OF AGRICULTURE

- *468 Hon. J.B. Chitekwe (Ntchisi East)** To ask the Minister of Agriculture to 2012 from Kalira EPA in order to facilitate smooth implementation of AIP since people from Kasakula have consider completely detaching Kasakula EPA which was instituted in to travel over 25 km to access agricultural services at Kalira EPA.

MINISTRY OF GENDER, COMMUNITY DEVELOPMENT AND SOCIAL WELFARE

- *471 Hon. R.G. Gadama (Zomba Thondwe)** To ask the Minister of Gender Community Development and Social Welfare to give the status of the EDC centre project which was given to Zomba Thondwe Constituency during the DPP regime but after the change of government, the project has commenced but the money has been trimmed from K4 million to K2 million, where has the other half gone?

With K2 million are we going to produce a standard structure conducive to our children? Has the budget been trimmed because this is a rural area? The structure in question is in T.A. M'biza, GVH Misiyasi, Nampwache ECD Centre.

***472 Hon. J. Malango (Dedza Central East)** To ask the Minister of Information and Digitalization to consider erecting network towers at the following sites:

***473 Hon. Sadala Y. Ibrahim (Nkhotakota South East)** To ask the Minister of Information and Digitalization to consider erecting a tower at the following areas:

- (i) Chiphaka Trading Centre;
- (ii) Chamalile area; and
- (iii) Manyamba Trading Centre.

These towers will help people of the following villages: Mtosa, Mulalo, Masewe, Mwalawambila, Chisaka, Kasipa, Nkumbaleza, Dambrumphia, Mgombe, Chadewa and many more.

The people of the stated areas are finding it very difficult to communicate with their family and friends due to lack of network.

***484 Hon. L.E. Patel (Mangochi South)** To ask the Minister of Information and Digitalization to consider erecting towers at the following centres where there is no network:

- (i) Chisopi; and
- (ii) Lidunde.

MINISTRY OF TRANSPORT AND PUBLIC WORKS

***479 Hon. J. Mwale (Mchinji Central)** To ask the Minister of Transport and Public Works if there are plans to maintain the following bridges which were washed away during the last rainy season:

MINISTRY OF HEALTH

***480 Hon. Santigo Phiri (Mulanje South)** To ask the Minister of Health to renovate Mulanje District Hospital hostels which were burnt by fire a long time ago.

***481 Hon. A.T. Ngalande (Balaka North)** To ask the Minister of Health to consider speeding up the upgrade of Mcherezo building at Kachenga Trading Centre which was already considered for upgrade to health centre.

***485 Hon. M. Mwambande (Karonga North)** To ask the Minister of Education to consider constructing a Community Day Secondary School at Ngana. It will serve over six primary schools. These schools are as follows:

- (i) Ighamba Primary School;
- (ii) Muwisi Primary School;
- (iii) Chiwira Primary School;
- (iv) Ngana Primary School;
- (v) Kalulu Primary School; and
- (vi) Ngisi Primary School.

Access to these schools is hampered by hills from around other places in the area.

***486 Hon. N. Poya (Zomba Ntonya)** To ask the Minister of Education to consider the construction of Chikala Secondary School in the area of Group Village Headman Majawa or Mbembesya (6 miles).

***487 Hon. B. Mwamlima (Mzuzu City)** To ask the Minister of Education as to when will the Ministry consider constructing a new University at the new site in Nkhorongo Ward. If my memory saves me well, Mzuzu University was a Teachers Training College.

MINISTRY OF JUSTICE

***489 Hon. A. S. Bongwe (Zomba Likangala)** To ask the Minister of Justice to consider renovating Mwambo Court and staff houses.

***490 Hon. C.M. Chipungu (Thyolo South West)** To ask the Minister of Justice to consider constructing new court offices at T.A. Changata and T.A. Mbawela's premises as all offices being used at the moment are health hazards.

***491 Hon. J. K. Bonongwe (Kasungu West)** To ask the Minister of Justice to consider constructing courts in the following:

- (i) Senior Chief Lukwa; and
- (ii) Senior Chief Kawamba.

MINISTRY OF LABOUR

***492 Hon. B. Msaka, SC (Machinga Likwenu)** To ask the Minister of Labour to consider opening the only Skills Development Centre (Technical College) in Machinga, whose construction is now complete, to enable the youth of Machinga acquire much-needed skills.

- *493 Hon. Dr. M.J. Boti (Lilongwe North West)** To ask the Minister of Labour to consider constructing a Technical College/Skills centre in the constituency especially now that land has already been identified.
- *494 Hon. G. Kwelepeteta (Zomba Malosa)** To ask the Minister of Labour to consider opening Domasi Works Centre as a community college. Youths travel to Msondole which is far from Zomba Malosa Constituency.

MINISTRY OF TRADE AND INDUSTRY

- *496 Hon. C. Kajawa (Lilongwe Mpenu Nkhoma)** To ask the Minister of Trade and Industry to consider constructing 10 commercial buildings each containing 20 rooms to facilitate youth empowerment in business ventures by renting the rooms at a concessionary rate. This would promote investment activities at grassroots level.

- (i) The Honourable Member for Mzimba South to ask the Minister of Finance as when the Treasury will refund/payback the 2020/2021 Constituency Development Fund monies that were misappropriated by Mberwa District Council which has negatively affected a number of issues as follows:
- (a) Numerous projects are unfinished whereby bringing unnecessary pressures to the Members of Parliament;
 - (b) Cheques to suppliers were returned at the bank and they have not been paid back; and
 - (c) Members of Parliament for Mzimba are failing to report to Area Development Committees on the utilization of the 2020/2021 financial year as per the CDF guidelines.
- (ii) The Honourable Member for Nkhotakota Central to ask the Minister of Water and Sanitation on the following issues;
- (a) What plans does the Ministry have to ensure that residents of Nkhotakota Boma have access to safe water just like was the case in the 1980s and 1990s when residents were supplied with safe and portable water from Lake Malawi and Chitenje Marsh. The two water sources have now become dysfunction due to abandonment and increased demand for farming land.

- (b) What measures government is putting in place to control urbanization due to population growth as the case with Nkhotakota Boma?
 - (c) What measures government is putting in place to ensure people of Jalo and Vithenga which are within the town planning area have access to safe water?
 - (d) Can government consider replacing one the three water tanks which was relocated to Dwangwa from Nkhotakota Boma which has increased water shortage due to increased population?
- (iii) The Honourable Member for Chitipa South to ask the Minister of Energy through the Ministry of Finance and Economic Affairs to release K20 billion from MAREP funds which have been idle for some time for immediate repair of Kapichira Power Plant. The Plant has been devastated due to Tropical Cyclone Ana which has led the country to lose 130 MW.

SONA Q4 Hon. Dr. William Susuwele Banda (Zomba Lisanjala) To ask the President as to what his plans are in order to ensure that some secondary schools which have not received funding since July, 2021 are properly funded. Our understanding is that the PDU is set up among other things to capture such outstanding issues. What is your comment on Government's failure to fund such schools and PDU not stepping in to address this matter.

SONA Q5 Hon. Darlington Harawa (Dowa Central) To ask the President, former President H.E. Joyce Banda commissioned a geo mapping study to determine mineral resources of the country:

- (i) The report, until now is not yet known yet your gut is prioritizing mining as one of the game changers - when will this report be out for the benefit of Malawians.
- (ii) In view of bridging the capacity gaps for local miners, can't our local banks be financially supporting them to enable them explore and extract minerals as a way of empowering them.

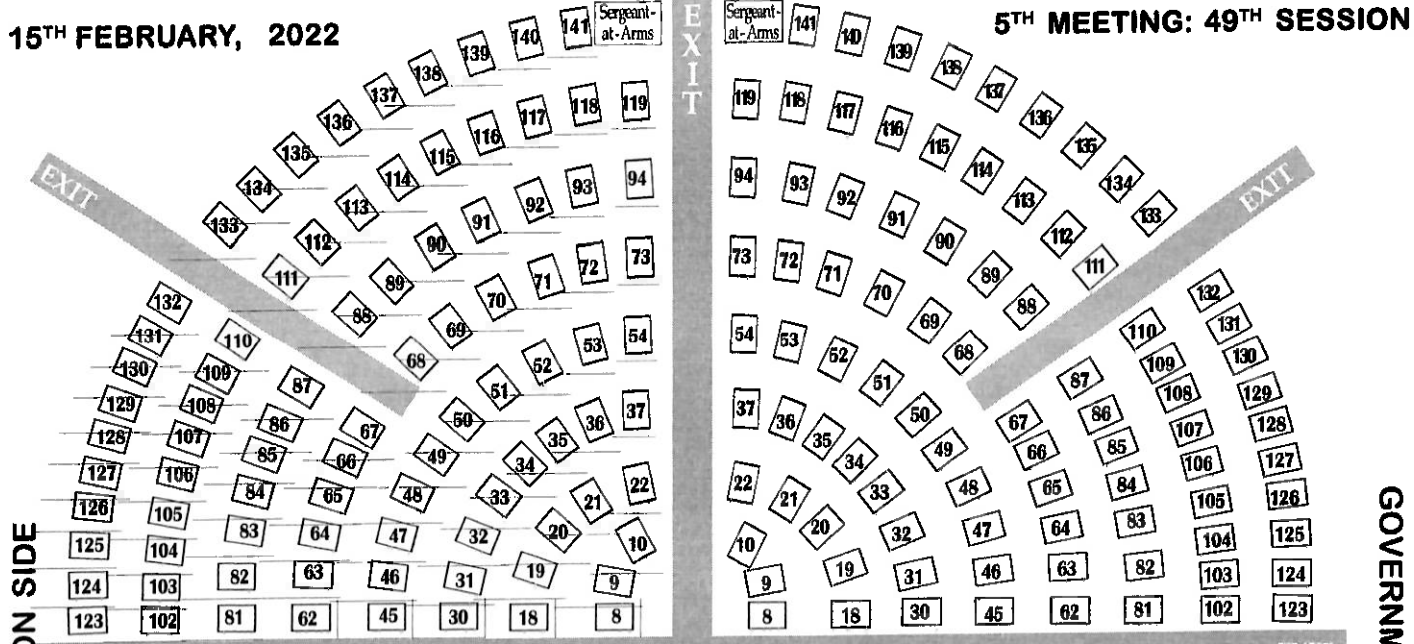
